

ORDINANCE NO. 1109

AN ORDINANCE OF THE BOROUGH OF NORTH BRADDOCK, ALLEGHENY COUNTY, PENNSYLVANIA, PROHIBITING TRASH DISPOSAL CONTAINERS, COMMONLY REFERRED TO AS DUMPSTERS AND "POD" TYPE TEMPORARY STORAGE CONTAINERS ON PUBLIC WAYS WITHOUT A PERMIT AND PROVIDING FOR FEES, PENALTIES AND EXEMPTIONS

WHEREAS, the Borough Council of the Borough of North Braddock has determined that parking trash disposal containers or storage containers commonly known as "pods" on public streets and sidewalks is a threat to the public, health, safety and welfare.

NOW, THEREFORE, be it ordained and enacted by the Borough Council of the Borough of North Braddock, Allegheny County, Pennsylvania, in meeting assembled, as follows:

SECTION 1. Permits Required. No person shall cause, allow, or authorize any dumpster, trailer, removable truck body, storage pod or any other such container or device that is used or intended to be used for the removal, transportation or storage of garbage, trash or debris or for the storage of personal property to be placed upon any public street, highway, alley or sidewalk without a permit.

SECTION 2. Permits. A permit shall be issued by the Borough Secretary or his representative upon completion of a permit application in accordance with uniform regulations adopted by the Borough Council and payment of a permit fee. The permit shall be valid for a single device described in Section 1, but that device may be emptied and replaced by another device without limit during the thirty days permit period or any renewal of that permit.

SECTION 3. Permit Fee. The permit fee shall be Fifty (\$50.00) Dollars for new permits and Twenty-Five (\$25.00) Dollars for each renewal, which fees may be changed for new permits by the Borough Council by resolution at any time.

SECTION 4. Permit Term. Permits shall be issued for a specified term, not in excess of thirty (30) days from the date the device is parked on the street, except for good cause shown, but

not in excess of six months.

SECTION 5. Exemption. This ordinance shall not apply to containers having a capacity of less than fifty-five (55) gallons placed at the curb for regularly or specially scheduled removal by the municipal collector.

SECTION 6. Penalty. Any person violating this Ordinance or the regulations adopted pursuant to this Ordinance shall be fined an amount not less than Fifty (\$50.00) Dollars and not more than Six Hundred (\$600.00) Dollars. Each day shall be a separate violation.

SECTION 7. Any ordinance or part thereof that may conflict herewith, or be repealed hereby, shall be and the same is hereby repealed.
